

EP27 100% ACRYLIC EMULSION PRIMER

Features:

A special formulated water based primer used as a base coat for E27 Acrylic Emulsion, designed to give a uniform base and eliminate "grinning" of the substrate thus producing a more uniformed finish. For use on porous surfaces such as all forms of moisture resistant boards, aqua board, plaster boards, plaster skims, cement render, asbestos and most forms of bricks but not Common or Engineering.

Colour Range:

In Creamy White & Mid-Grey as standard. Other colours made to order in minimum of 20.0 Litres to suit dark or brightly coloured topcoats.

Pack Size:

In 5.0 Litre containers. Orders over 80.0 Litres will be sent in 20.0 Litre drums to avoid tin waste.

Availability:

Please note all our products are made to individual order, however we keep a limited stock of this product on the shelf but it may take 4-7 days before shipping larger orders. It should be noted that we recommend you do not issue instructions of work to contractors before you have taken delivery of your goods, as delays in delivery are out of our control.

Technical Data:

VOC-content:15g/Litre max.EU Limit values:15g (2010/42/CE Class Ai).VOC Content (as supplied):max 15g/Litre.

Volume Solids: $24\% \pm 3\%$ (BS 3900 Part A10).

Film Thickness: (depending on method of application)Wet:70 Microns.Dry:25-30 Microns.

Drying:

Touch dry:	1 Hour @ 20°C. 3 hours @ 10°C.
Recoatable:	4 hours @ 20°C. 12 hours @ 10°C.

Important: when over coating with any solvent based coating, EP27 primer must be left overnight before coating to allow moisture to leave the substrate.

Minimum application temperature 8°C. Relative humidity should be no greater than 85%.

Coverage:

Up to 35-40 sq. metres per 5.0 Litres.

Coverage rates are based on our own tests but could vary depending on surface profile, porosity of the surface and method of application. Please ensure you have the correct amount of product to complete the job before starting. Coloured finishes should only be applied from the same batch of paint. Where more than one batch is available, all batches should be boxed together before applying to maintain continuity of colour and finish.

Preparation:

The surface should be clean, dry and free from dust and grease. Concrete surfaces should be a minimum of 6-8 weeks old before being painted. Plaster surfaces should be completely dry before applying EP27 primer.

Application:

Brush, roller, or airless spray. Supplied ready for use for brushing and rolling. When applying by roller, only use a good quality synthetic medium pile or sheep skin roller. To aid penetration on very absorbent surfaces, it is recommended that a first coat is applied thinned up to 20% by volume with clean tap water.

EP27 should not be over-brushed or over-rolled; the coating should be applied, laid off and left. For spray application we recommend you contact your spray equipment supplier.

Health & Safety: Please see MSDS sheet 100C3.

PLEASE NOTE: YOU SHOULD NOT ATTEMPT SPRAY APPLICATION UNLESS YOU ARE A QUALIFIED, PROFESSIONAL SPRAYER.

If you are unsure about any of the procedures or have any questions, please call or email our Technical Team. We always recommend that a trial adhesion test is carried out to ensure suitability of the product on the surface you are trying to coat. Please contact our Technical Team if you are in any doubts before proceeding and please remember surface preparation is one of the key factors in achieving a good paint finish. This is time well spent as you will be rewarded with a better finish.

Important Note:

For internal and external work, maximum ventilation is required. To assist drying if the air flow is insufficient, fans or other mechanical methods of circulating air should be adopted. Precautions must be taken to prevent operators from inhaling the vapours during application; this may need the assistance of a second operative to monitor the first operative when carrying out application of pre-treatment and coatings. Please ensure PPE requirements are followed at all times.

Most of our products are for professional and trade/contractor use only and are not intended for DIY application. Before using any product, please read the appropriate Material Safety Data Sheet stated above. This important document is available to download from our Technical Paint Services web site. Carry out a full risk assessment for the intended use and method of application. If you are unable to carry out a risk assessment then you should contract someone qualified to carry this out for you, you should not proceed otherwise; it is your responsibility for the health and safety of yourself and others.
